GOVERNMENT BILLS

FIRST AND SECOND READING

- 1. A Bill for an Act to amend the Constitution (Declaration of Compatibility) Act 2009 to permit non-governmental organisations to apply to the Supreme Court for a declaration regarding compatibility in respect of Bills which directly affect a non-governmental organisation or its members. (B04/2016)

- 2. A Bill for an Act to make provision for the disclosure of information held by public authorities or by persons providing services for them and for connected purposes. (B39/2015)
