### FIRST AND SECOND READING

- 1. A Bill for an Act to amend the Constitution (Declaration of Compatibility) Act 2009 to permit non-governmental organisations to apply to the Supreme Court for a declaration regarding compatibility in respect of Bills which directly affect a non-governmental organisation or its members. (B04/2016)

- 2. A Bill for an Act establishing the Gibraltar Consultative Council and governing its functions and duties, and prescribing the terms of membership of the same. (B09/2016)

- 3. A Bill for an Act to repeal the Magistrates' Poor Fund Act and make provision to the dissolution of the charitable trust constituted by such Act. (B16/2016)

A Bill for an Act to amend the Partnership Act and the Trustee Act to impose criminal penalties for the failure to maintain proper books of accounts or records identifying settlors, trustees and beneficiaries; and to amend the International Co-operation (Tax Information) Act 2009 to impose a criminal penalty in respect of breaches of confidentiality and provide an exemption from the requirement to notify the subject of a request of a notice issued under section 8; and for connected purposes.
