FOR

AN ACT to amend the Commonwealth Park Act 2014.

ENACTED by the Legislature of Gibraltar.

Title.

1. This Act may be cited as the Commonwealth Park (Amendment) Act 2022.

Commencement.

2. This Act comes into operation on the day of publication.

Amendment of the Commonwealth Park Act 2014.

3.(1) The Commonwealth Park Act 2014 is amended in accordance with this section.

(2) In the long title, after “COMMONWEALTH PARK” insert “AND A PARK TO BE KNOWN AS CAMPION PARK”.

(3) In section 1, for “Commonwealth Park Act 2014” substitute “Commonwealth and Campion Parks Act 2014”.

(4) After section 2, insert—

“Establishment of Campion Park.

2A. There is hereby established a park to be known as Campion Park.”.

(5) In section 3, after “Commonwealth Park” insert “and Campion Park”.

(6) In section 4, -

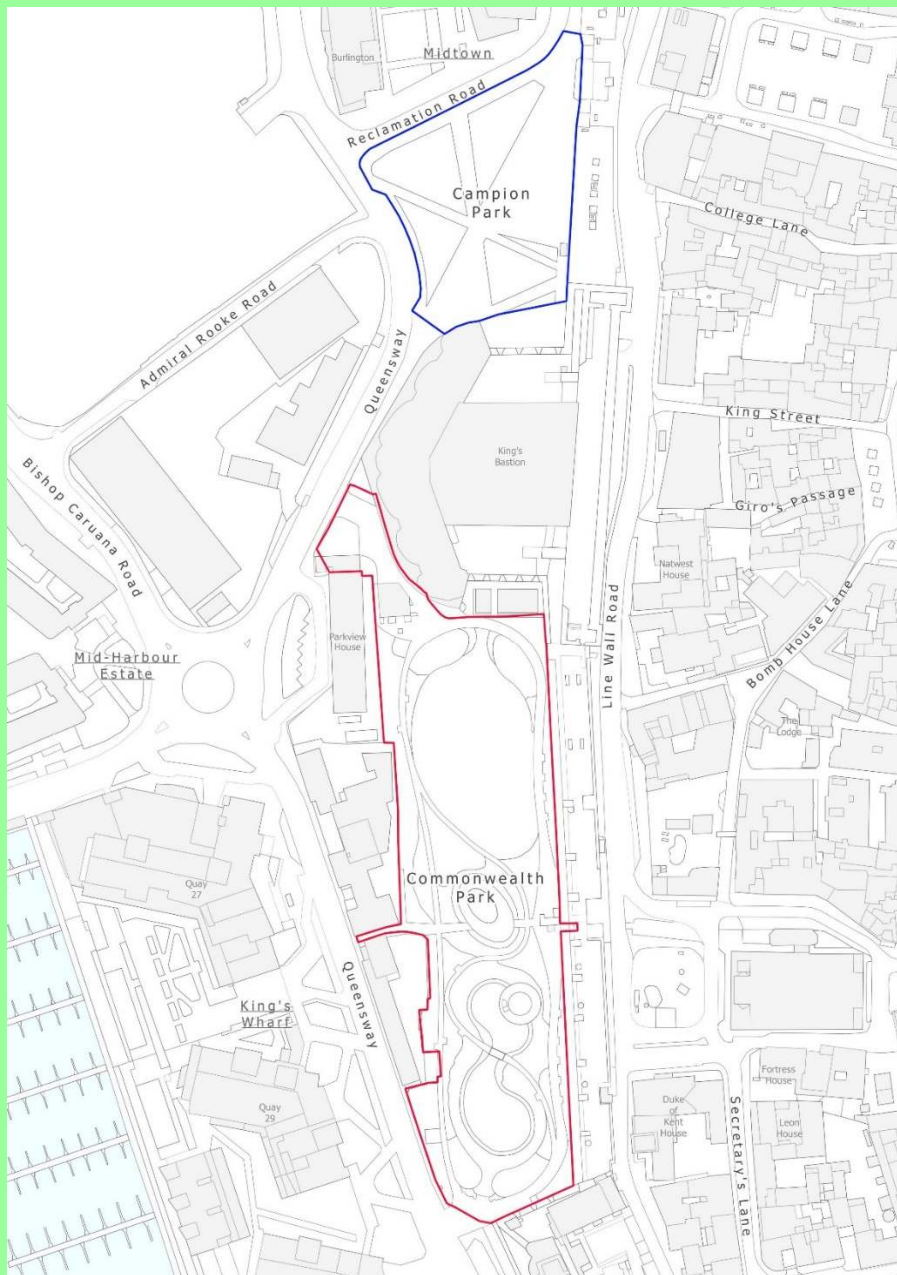
(a) for “4.” substitute “4.(1)”;

(b) after the newly renumbered subsection (1) insert-

“(2) Campion Park comprises the area delimited in blue in the Schedule to this Act.”.

(7) The plan contained in the Schedule is deleted in its entirety and substituted with the following plan—

Amendment of the Commonwealth Park Rules 2014.

4.(1) The Commonwealth Park Rules 2014 are amended in accordance with this section.

(2) In rule 1, for “Commonwealth Park Rules 2014” substitute “Commonwealth and Campion Parks Rules 2014”.

(3) In rule 2-

(a) in the definition of “central fountain” after “means” insert “, in respect of Commonwealth Park,”;

(b) for the definition of “central pathway” substitute-

““central pathway” means,

(a) in respect of Commonwealth Park, the east-west pathway that transects the park as demarcated by broken red lines in the Schedule;

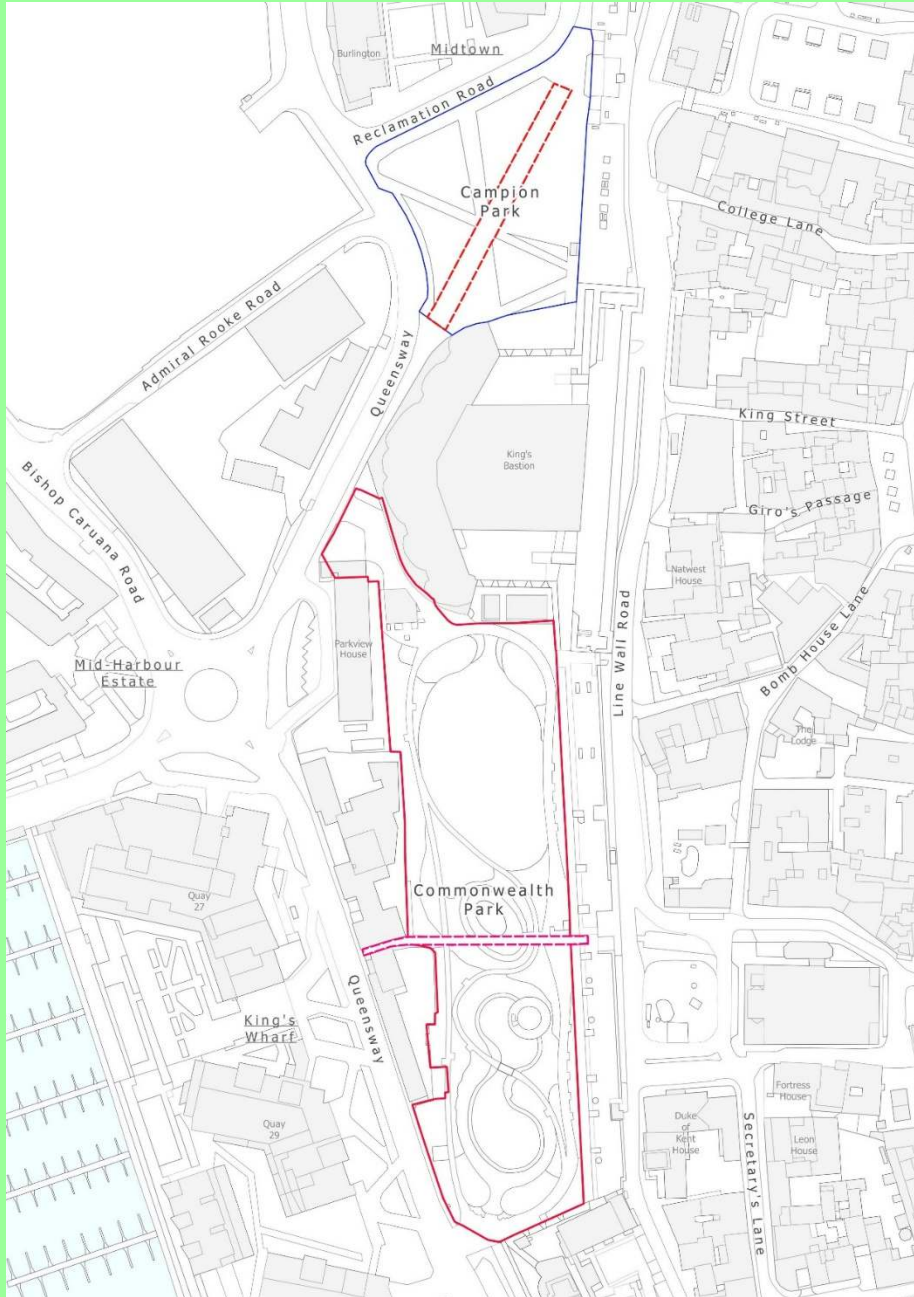
(b) in respect of Campion Park, the south-west to north-east pathway that transects the park as demarcated by broken red lines in the Schedule;

(c) for the definition of “park”, substitute—

““park” means Commonwealth Park or Campion Park, the respective boundaries of which are set out in the Schedule to the Commonwealth and Campion Parks Act 2014;”.

(4) The plan contained in the Schedule is deleted in its entirety and substituted with the following plan-
