GHA – LONG-STAY ELDERLY PATIENTS AT ST BERNARD’S HOSPITAL

Can the Minister for Health state how many beds are presently taken up at St Bernard’s Hospital by long-stay elderly patients awaiting a place at the Care Agency?

ANSWER

The number of beds held in SBH by long-stay elderly/complex cases awaiting transfer to the Care Agency are as follows:

Complex Elderly	25	Highly likely to require long term care at different stages of the discharge process.
Long Stay Elderly	33	Medically discharged & pending transfer
Dementia	21	Highly likely to require long term care some of which are already discharged & pending transfer.
Total	79	Out of 120 acute adult beds (excluding CCU)

Note: Figures change on a daily/weekly basis for the following reasons:

- Patients are transferred to The Care Agency;
- New patients are admitted with complex discharge needs;
- Patients die.
