Can the Minister for the Environment state which recommendations have been implemented and which ones have not from the 'Upper Rock Nature Reserve: A Management and Action Plan, (2005), written by Mr. Charles E. Perez and Mr Keith J. Bensusan?

ANSWER

The Upper Rock Management Plan was adopted by this Government in 2012 and used as the basis for designating the Rock of Gibraltar Site of Community Importance (SCI) as an EU Special Area of Conservation (SAC). Since then, the plan has been used as an interim framework until the newly revised Gibraltar Nature Reserve Management Plan is published later this Spring. The new plan contains a wide range of recommendations for the Upper Rock and other areas of ecological importance in Gibraltar that were recently afforded protected area status under the Nature Conservation (Designation of Gibraltar Nature Reserve) Order 2013. These areas include Windmill Hill, the Mount, Jacob's Ladder, Northern Defences, Sand Slopes, the Talus and Europa Foreshore. Although the revised plan is still being finalised, a large number of measures included within the new plan have already been implemented or initiated including but not limited to:

- 1. Improving visitor access and restoring paths within the Upper Rock;
- 2. Improved firebreak clearing programme including the creation of new firebreaks;
- 3. Removal of old signage and installing new, uniform signage including Nature Reserve demarcation, traffic awareness and tourist information signs;
- 4. Installing new balustrades and restoring road barriers;
- 5. Creating re-population and re-introduction facilities within the Upper Rock
- 6. Re-populating key species within the Upper Rock such as the Barbary Partridge (*Alectoris barbara*) and the Wild Rabbit (*Oryctolagus cuniculus algirus*).
- 7. Increasing resources for the Department of the Environment's Environmental Protection and Research Unit;
- 8. Increasing resources for the Upper Rock Management Team;
- 9. Increasing security in the Upper Rock i.e. dedicated environmental security guards and installing time-lapse surveillance cameras;
- 10. Creation of new picnic areas;

Can the Minister for the Environment say how many soil and water samples in different sites were monitored by the Department of the Environment during 2014/2015, and provide a summary of the locations and the results thereof?

ANSWER

A total of 950 water samples have been taken and analysed during the period 2014/15. Sampling works are carried out every month by means of the Department of the Environment's monitoring and surveillance programmes. The following is a summary of the main water quality monitoring programmes currently managed by the department:

- 1. Coastal Water Monitoring monitoring and sampling of Gibraltar's coastal waters is carried out in compliance with the Water Framework Directive (WFD) and the Marine Strategy Framework Directive (MSFD). The programme is carried out on a monthly basis by the department's technical officers. The programme consists of collecting water samples from specific monitoring sites which then undergo laboratory analysis in the UK. Additionally, a number of in-situ measurements are taken at each site. Water quality parameters that are monitored include physio-chemical quality elements, chemical elements and biological quality elements (e.g. phytoplankton). Sampling is carried out approximately 100m from the shore in a total of 6 core sites which include:
 - Eastern Beach (South)
 - Catalan Bay (North)
 - Sandy Bay
 - Camp Bay
 - Gibraltar Harbour
 - Western side of the runway (North West)

The results of the water samples analysed during 2014/15 indicate that the Gibraltar Coastal Waters are generally of good status and are consistent with past results.

- 2. Groundwater Monitoring The department routinely monitors a number of groundwater wells located in both the northern isthmus aquifer and southern bedrock aquifer. Monitoring and sampling of these wells is carried out in compliance with the WFD. The monitoring consists of taking measurements of the groundwater's physical parameters every month and collecting water samples from each well on a quarterly basis. Samples are currently taken from 5 sites which include:
 - Silent Pool / Ragged Staff Magazine (southern aquifer)
 - North Front Cemetery (northern aquifer)
 - Frontier Fence by the eastgate (northern aguifer)
 - Four Corners (northern aquifer)
 - Runway / opposite Cepsa petrol station (northern aguifer)

Results of the water samples analysed during 2014/15 indicate that the two groundwater bodies are at good status and are consistent with past results.

No soil samples have been taken during 2014/15. Soil sampling is carried out on an ad-hoc basis where required and / or necessary.
