ANSWER

To go back over the financial years in questions and try to extract from the records of the time the monthly income and expenditure of the consolidated fund would involve a major deployment of staff in the Treasury which would entail moving them away from their existing duties and as far as the government is concerned the effort and cost off such an exercise is totally unjustified. The years 12/13, 13/14, 14/15 relate to accounts which have already been closed. In respect of the current financial year, the position of the GSD in government throughout the 15 years was that they were only prepared to provide the opposition with a snapshot of the ongoing expenditure as at 30 September. This provided a limited amount of information based on expenditure heads. In addition, given the time that was required to produce such statistics the information was provided by the previous administration on the basis that it would take some three months, which meant it was provided in January, when there happened to be a meeting of the Parliament in that month. This 6 month snapshot can be provided if requested.

Can the Minister for Public Finance please provide a copy of the latest full (including notes) consolidated financial statements for Gibraltar Investment (Holdings) Ltd and Gibraltar Joinery and Building Services Ltd and Gibraltar Strand Property Company Ltd?

These companies, as all others, are required to file accounts with the companies Registry. The information which the Honourable Member is seeking will therefore be made available not just to him but to the Community as a whole when the accounts are filed. Unfortunately, given that the former GSD administration failed to comply with the legal obligation to file accounts for these companies for a number of years, we are still in the process of catching up with the GSD's failure to provide transparent and accountable access to this information. We are nevertheless working to ensure we correct that anomaly created by the party opposite when they were in power.
