For the year 2019, how many people in receipt of disability benefit have had their benefit reduced because they are employed or otherwise earning from being trained either in the public or private sector?

As at the end of December 2019, 391 persons were in receipt of disability benefit.

Of the 391 persons, 244 were not in employment, 77 were under the age of 18 and not in employment and 70 were employed of which 33 by Supported Employment Company.

Of the 70 persons employed who are in receipt of disability benefit, 42 are in employment for over 20 hours a week and receive 25% of the benefit and 28 are in employment for 20 hours or less a week and receive 62.5% of the benefit.

The individual mentioned by the honourable member in his supplementary was not someone in employment in 2011 as he stated. Had he been the whole of his disability allowance would have been removed by the GSD government as they had done to others.

He was someone treated as a vocational cadet under the Vocational Training Scheme, without an employment contract even though he was not being provided with any training at the time.

He received the disability allowance which had not been removed because he was not in employment and was receiving a trainee allowance well below the national minimum wage. When we gave him an employment contract in 2012 his trainee allowance was replaced by a salary at the national minimum wage and because of the new policy adopted by the GSLP government following its manifesto commitment, his disability allowance was not removed but reduced. The reduced disability allowance and the national minimum wage paid as his salary together provided him with an income that was considerably higher than the income paid in 2011 with the allowance as a trainee and the full disability allowance.

This improved income was provided to him and 47 others.

All these so-called trainees remained after 2011 in the placements where they had been previously undertaking the same activities as before but now as employees with employment contracts and employment rights, on a much higher level of income. This improvement was at the time welcomed by the honourable questioner when it was introduced in 2012 with a reduction in the disability allows but a much higher level of total income.

The number of applications for disability benefit rejected between 2015 and 2019 were 44 in 2015, 38 in 2016, 49 in 2017, 35 in 2018 and 21 as at the end of 2019. It should be noted that with regard to applications received in 2019, 28 applications are pending assessment and there are 10 appeals pending so the figure for 2019 may change.

Of all applications received, 8 referred to an autism related disability in 2015, 9 in 2016, 8 in 2017, 13 in 2018 and 13 in 2019.

In 2012, no one had their disability allowance reduced for participating in a Government training scheme. 16 people had their disability benefit reduced because they were in employment.

In 2019, 4 people were in receipt of disability benefit and had it reduced due to their subsequent employment of which:

- 2 people were employed for over 20 hours a week and now receive 25% of the benefit
- 2 people were employed for 20 hours or less a week and now receive 62.5% of the benefit.

In 2019, 11 new cases were approved from people who were already in employment of which:

- 9 people are employed for over 20 hours a week and receive 25% of the benefit
- 2 people were employed for 20 hours or less a week and receive 62.5% of the benefit.

Access to images is limited to senior management in the schools and JT Security Ltd who provide security services to the schools.

The use of the CCTV and any images generated by the CCTV is subject to the provisions of the Data Protection Act 2004 and to guidance issued by the GRA under Guidance Note 17/07 entitled Guidance for Users of CCTV Systems.

The Guidance Note provides that in order to comply with the provisions of the Act and its underlying principles, there must be a fair and lawful basis for using CCTV systems. The Note gives examples of lawful bases allowed for in the Act as follows:

- Prevention, investigation and detection of crime
- Apprehension and prosecution of offenders
- Public and employee safety
- Security of premises

The use of CCTV in schools is subject to all the limitations, safeguards, enforcement procedures and remedies set out in the Act as well as the guidance contained in Guidance Note 17/07.

JT Security Ltd is subject to strict obligations of confidentiality and compliance with the law. Any failure to comply with this would amount to a serious breach of their agreement with Government and a gross dereliction of their duties.

In addition to the legal and contractual frameworks, the Department of Education is in the process of drafting a policy for the governance of the use of CCTV systems in schools.

The Government's policy is to continue to provide multiple continuous professional development (CPD) opportunities for teachers.

CPD is not only an occasion for teachers to develop new knowledge and skills but also an opportunity to train to the latest and best methods of teaching our children, ensure that they become aware of curriculum and examination requirements and attend to the welfare and wellbeing of children and staff.

CPD is facilitated throughout the academic year and particularly during the 5 mandatory inservice (inset) days. CPD is managed and arranged by the Department of Education in accordance with the needs of the service and of schools.

All costs are specifically covered under the CPD training budget of £70,000 as reflected in the approved estimates for 2019/2020. Requests are submitted by schools and recommended by Headteachers as they are needs led.

As also appears in the approved estimates, the Department of Education has a further training budget this year of £156,000 to cater for a teaching and learning initiative using digital technologies. In addition, the Department of Education manages a specific training and resource budget for Special Educational Needs (£30,000) and for the Educational Psychology department (£7,000).

The maximum salary for Headteachers and Deputy Headteachers is determined by school groups. School groups are calculated by the size of the school and the age of its pupils.

<u>Group 2</u> Deputy Headteachers – £73,497 Headteachers - £ 84,699

<u>Group 3</u> Deputy Headteachers – £77,180 Headteachers - £ 88,950

<u>Group 7</u> Deputy Headteachers – £96,225 Headteachers - £116,911
