

SOCIAL SECURITY (OPEN LONG-TERM BENEFITS SCHEME) ACT 1997

**SOCIAL SECURITY (OPEN LONG-TERM BENEFITS SCHEME)
(AMENDMENT OF BENEFITS) ORDER 2018**

In exercise of the powers conferred on him by section 46 of the Social Security (Open Long-Term Benefits Scheme) Act 1997, and all other enabling powers, and with the prior approval by resolution of the Gibraltar Parliament, the Minister has made the following Order—

Title and commencement.

1. This Order may be cited as the Social Security (Open Long-Term Benefits Scheme) (Amendment of Benefits) Order 2018 and shall be deemed to have come into operation on 1 August 2018.

Amendment of the Social Security (Open Long-Term Benefits Scheme) Act 1997.

2.(1) The Social Security (Open Long-Term Benefits Scheme) Act 1997 is amended in accordance with the provisions of this paragraph.

(2) Section 22(a) is amended by substituting “£226.26” with “£231.95”.

(3) Schedule 2 is amended by substituting Part 1 with the following –

“PART I

Section 11(2)

STANDARD RATES OF BENEFITS AND OF INCREASES FOR DEPENDANTS

(a) where the pension is payable to a woman by virtue of a husband's or civil partner's insurance, and he is alive, or where the pension is payable to a man by virtue of his wife's or civil partner's insurance and she is alive.	£231.95	-	£67.05
(b) in any other case.	£463.75	£231.95	£67.05

* Except in the case of a Widowed Parent's Allowance where there is no limit to the number of children in respect of whom increases may be paid.”.
