## BOARD OF CHARITY COMMISSIONERS FOR GIBRALTAR ANNUAL REPORT FOR 2019

- 1. The Board of Charity Commissioners for Gibraltar ("the Board") met four times during 2019.
- 2. The tenure of the Board expired in June 2019. The Board was re-appointed for the period ending June 2020.

The Secretaries appointed to the Board were Louise-Anne Canepa and Mrs Giselle Corby for the period ending June 2020.

- 3. Following the two meetings held in 2017 between the Board and a representative of the Office of the National Coordinator for Anti-Money Laundering and Terrorist Financing, the Terrorist Risk Financing Assessment was subsequently submitted to the Committee of Experts on the Evaluation of Anti-Money Laundering Measures and the Financing of Terrorism (MONEYVAL). The Fifth Round Mutual Evaluation Report on Gibraltar was published in December 2019, wherein it was stated in the Report's "Weighting and Conclusion" section relating to Charities, that "Overall, four criteria are met, one criterion mostly met and one partly met", and rated Largely Compliant.
