

BOARD OF CHARITY COMMISSIONERS FOR GIBRALTAR
ANNUAL REPORT FOR 2020

1. The Board of Charity Commissioners for Gibraltar ("the Board") met only three times during 2020 as a result of the COVID-19 pandemic.
2. At the second meeting of 2020, the Chairman opened the meeting by informing the Members present, of Mr Francis Isola's wish not to be re-appointed as Charities Commissioner on the expiration of his current appointment. The Chairman requested that it be recorded in the Minutes, his thanks on behalf of the Charities Commission to Mr Isola, for all those years that he had so generously contributed to the role of Commissioner of Gibraltar Charities. The Chairman made special mention of Mr Isola's meticulous work on the Charities' accounts and valuable input in all other related matters.

The Chairman also introduced Mr Jose Julio Pisharello as incoming Commissioner and thanked him for accepting the appointment.

3. The tenure of the Board expired at the end of June 2020. The Board was re-appointed with the exception of Mr Francis Isola, and Mr Jose Julio Pisharello appointed for the period ending June 2021.
