The functions of the Council are—

- (a) to make its views known to the Minister on how to promote and secure the conservation, protection and enhancement of Gibraltar's heritage, antiquities or objects of interest, monuments or buildings, and historical conservation and archaeological areas;
- (b) to foster understanding and facilitate the enjoyment of Gibraltar's heritage, antiquities or objects of interest, monuments or buildings, and historical conservation and archaeological areas;
- (c) to advise on anything which is to be done in relation to antiquities or objects of interest, monuments or buildings or historical conservation and archaeological areas, including advice that such activity always be carried out in a sustainable manner by a suitably qualified person; and
- (d) to identify present and future issues which require or may require addressing in relation to heritage, antiquities or objects of interest, monuments or buildings and historical conservation and archaeological areas.
- (2) The Council shall advise the Minister on matters relating to heritage, antiquities or objects of interest, monuments or buildings, historical conservation and archaeological areas it wishes to or which the Minister may refer to the Council.

Council to take account of certain matters.

- 8. It shall be the duty of the Council, in carrying out its functions under section 7(1) and (2), to take account, as may be appropriate, of—
 - (a) actual or possible ecological and other environmental changes affecting heritage, antiquities or objects of interest, monuments or buildings and historical conservation and archaeological areas;
 - (b) the need for social, cultural and economic changes in Gibraltar;
 - (c) the interests of the community in general.

HAAC MEETINGS.

There have been a total of 6 meetings in this period, one in 2018 and 5 in 2019.

The Ministry for Heritage together with its heritage partner's focused primarily in bringing a working structure and system to the new act as the previous act was mainly concerned with the establishment of the heritage trust, its function and composition.

The Heritage and Antiquities Act 2018 and the establishment of the Heritage and Antiquities Advisory Council now allowed for much greater control and supervision over our built heritage and underground archaeology.

To celebrate the enactment of the act a Heritage Moratorium was put in place in order to allow individuals to hand in artefacts they had found which would constitute an offence under the new act.

The Heritage Moratorium was a success, items were catalogued and following recommendations from the Curator, decisions were made on what should be returned and what should be kept for the benefit and enjoyment of the community.

A new enhanced working relationship between law enforcement and heritage stakeholders was also established as part of the heritage act working structure.

The Heritage and Antiquities Advisory Council (HAAC) was very active in between meetings as it was soon discovered that the workload was quite extensive and many decisions could not wait for the next scheduled meeting. With this in mind, a system of round robin emails/mailings was initiated in order to consult between members. This proved invaluable in being able to provide timely advice to the Minister for Heritage and not delay the decision making cycle.

Any decisions made in between meetings were included into the minutes so there was an official record.

This has assisted both Government and developers in streamlining operations, especially as the Council feeds in directly to the Town planning process.

The bulk of the work carried out by the Council has been in the advice to the Minister for the issue of Heritage Licences that are required to perform any works on Listed Sites.

It should be noted that HAAC took over from the Heritage Action Committee (HAC) that had been in existence for many years and was the precursor of the issuing of licences in accordance with the previous Act.

Please note that HAC still exists as a committee and will meet if any emergency arises.

One of the first functions of HAAC was to disseminate the main differences in legislation to stakeholders and this was done through direct briefings and the press.

Another of the main points was the improvement of relations with the MOD as there are several sites under their control that have potential for listing. This work is on-going and includes HQBF the Tower, Batteries and fortifications at Buffadero amongst others.

HAAC has also allowed for greater integration between the agencies represented, such as the Ministry for Heritage, Gibraltar Heritage Trust, Gibraltar National Museum, Gibraltar National Archives and the Town Planning Department.

Archaeological monitoring, restoration, heritage assessments and technical advice through the planning system continued and enhanced further still.

Examples of heritage projects include:

- 1. First phase of works at Nuns' Well
- 2. First phase of the Heritage Environment Record (HER) and the GIS layering of our listed sites
- 3. The restoration and interpretation of the Europa Foreshore
- 4. The restoration and interpretation centre at the ex 'du farol' site
- 5. First phase of the restoration of Southport Gates
- 6. The restoration of the Almond Tower
- 7. The restoration of the Garrison Library balustrade
- 8. The restoration of the southern defensive wall at Parson's Lodge
- 9. The restoration and subsequent relocation of the ex MOD Gatehouse
- 10. First phase of the restoration of the Old Mole Head
- 11. The restoration of the Larios Family Dresser
- 12. First phase of the restoration of Ford Canada
- 13. Continued restoration of the Northern Defences
- 14. Important archaeological discoveries due to enhanced supervision such as ancient shipwreck finds, Europa point Islamic medieval finds and the Torre del Molino amongst others

In 2018/2019, the Minister on advice from HAAC issued 12 Heritage Licences and 4 Export Licences. Only two Heritage Licences have had to be extended due to non-completion of works.
