The functions of the Council are-

- (a) to make its views known to the Minister on how to promote and secure the conservation, protection and enhancement of Gibraltar's heritage, antiquities or objects of interest, monuments or buildings, and historical conservation and archaeological areas;
- (b) to foster understanding and facilitate the enjoyment of Gibraltar's heritage, antiquities or objects of interest, monuments or buildings, and historical conservation and archaeological areas;
- (c) to advise on anything which is to be done in relation to antiquities or objects of interest, monuments or buildings or historical conservation and archaeological areas, including advice that such activity always be carried out in a sustainable manner by a suitably qualified person; and
- (d) to identify present and future issues which require or may require addressing in relation to heritage, antiquities or objects of interest, monuments or buildings and historical conservation and archaeological areas.

(2) The Council shall advise the Minister on matters relating to heritage, antiquities or objects of interest, monuments or buildings, historical conservation and archaeological areas it wishes to or which the Minister may refer to the Council.

Council to take account of certain matters.

8. It shall be the duty of the Council, in carrying out its functions under section 7(1) and (2), to take account, as may be appropriate, of–

- (a) actual or possible ecological and other environmental changes affecting heritage, antiquities or objects of interest, monuments or buildings and historical conservation and archaeological areas;
- (b) the need for social, cultural and economic changes in Gibraltar;
- (c) the interests of the community in general.

HAAC MEETINGS

The Heritage and Antiquities Advisory Council held six meetings in 2022.

The Ministry for Heritage together will all relevant heritage stakeholders enjoyed a very successful year.

Archaeological monitoring, restoration, heritage assessments and technical advice through the planning system continued and enhanced further still.

Examples of heritage projects include:

- 1. The transfer and restoration of the last 25-pounder QF Field Guns in Gibraltar, now on display at the 100 Ton Gun Visitor Centre together with information panels.
- 2. The recovery of the 9.2. Inch gun barrel, carriage and pedestal which was dismantled from Levant Battery and left at the scrapyard for over 50 years.
- 3. Restoration of Lord Airey's Battery.
- 4. The restoration of the City Under Siege Exhibition and the installation of 11 new interpretation panels.
- 5. The restoration and removal of vegetation at the Tower of Homage.
- 6. The placement of interpretation panels within the old town highlighting our medieval history.
- 7. The restoration of the last whipping post in Gibraltar, located outside the Shrine of our Lady of Europe.
- 8. The protection of Graves of Historical Interest.
- 9. The publishing of Cultural Heritage Town Planning Guidance Notes for all matters relating to assessments, permits and archaeology.
- 10. The continuous addition of maps, surveys and historical research pertaining to our Historic Environment Record on the Ministry for Heritage Website.

The discussion on improvements to physical assets as well as to policy and legislation does not cease.

We are currently working on other projects and improvements such as:

- 11. Amendments to the Heritage and Antiquities Act 2018 in order to afford greater control over the use of metal detectors, excavations as well as the imports/exports of antiquities.
- 12. The creation of a register of Historic Buildings.
- 13. The restoration of the Convent Main Façade.
- 14. The restoration of Southport Gates.
- 15. The restoration of the main façade of the new St. Mary's School.
- 16. The fabrication of Gun Carriages.
- 17. 10 new interpretation panels to be placed at Southport Gates as well as at Camp Bay.
- 18. The restoration of O'Hara's Battery.
- 19. Works on the Medieval Gatehouse.
- 20. The establishment of a working relationship with the American Battle Monuments Commission in order to discuss improvements to the American War Memorial.

The council's work in partnership with all stakeholders, NGO's and private developers continues to evolve and goes from strength to strength.

Internal meetings amongst stakeholders as well as with the Minister for Heritage takes place regularly either in person or remotely via zoom or other platforms.

The provision of heritage licences continued to be successfully discussed via round robin email, with 12 licences given for works on listed sites.
