BELIEVES that there should be a cross-party approach to the issue of mental health;

ESTABLISHES a Select Committee on Mental Health to report to Parliament on such further improvements to mental health service provision in Gibraltar which it considers should be made generally and having regard to the recommendations set out in the Public Health England "Mental Health Situational Analysis Report" of April 2019;

RESOLVES that the Select Committee on Mental Health be composed of five members three of whom shall be drawn from the Government benches and two from the Opposition benches, one from each of the parties with representation."

## THIS HOUSE:

NOTES the presentation before the United Kingdom Parliament by way of a Private Members' Bill for a Bill to declare British Sign Language an official language of the United Kingdom; to provide for a British Sign Language Council to promote and advise on the use of BSL; to establish principles for the use of BSL in public services; to require public bodies to have regard to those principles and to guidance issued by the Council; and for connected purposes.

RECOGNISES and ACKNOWLEDGES the huge challenges faced by our deaf and hearing loss community in being heard, listened to and understood.

ACKNOWLEDGES the tireless work of members of the Gibraltar Hearing Issues and Tinnitus Association and the wider deaf and hearing loss community in raising awareness of the issues affecting the lives of the hearing impaired past and present.

AND CALLS on the Government to bring a Bill before the House to declare British Sign Language an official language of Gibraltar; to provide for a statutory body to promote and advise on the use of BSL; to establish principles for the use of BSL in public services; to require public bodies to have regard to those principles and to guidance issued by the statutory body; and for connected purposes.
